RESOLUTION FOR JOINING THE ADDISON COUNTY SOLID WASTE MANAGEMENT DISTRICT

WHEREAS, the Selectboard of the Town of Bristol is closing a landfill and wishes to become a member of the District; and

WHEREAS, the District is a union municipal district that was created and exists for the purpose of providing a comprehensive system for managing solid waste generated within its member municipalities; and

WHEREAS, the district is governed by 24 VSA Appendix, Chapter 401, the governing charter of the District.

Now, THEREFORE, it is hereby resolved by the Selectboard of the Town of Bristol, by vote of a majority of those members present and voting at its regular meeting held on Monday, July 6, 2015, hereby orders the submission of a proposition for entering into an Admission Agreement with the District and joining the District, be submitted to the qualified voters of the Town of Bristol in the following form:

ARTICLE 1: Shall the voters of the Town of Bristol enter into an Admission Agreement with the Addison County Solid Waste Management District as approved by the Selectboard at their Monday, July 6, 2015 meeting? (Copies of the Admission Agreement are on file at the Town Clerk's office and copies are available to the public upon request and at the Town website at www.bristolvt.org.)

ARTICLE 2: Shall the Town of Bristol join the Addison County Solid Waste Management District?

IT IS FURTHER RESOLVED that a vote on said proposition shall be conducted by Australian Ballot from 9:00 AM to 7:00 PM on August 25, 2015 at Holley Hall.


ARTICLE 2: Shall the Town of Bristol join the Addison County Solid Waste Management District?
