Hi Megan

As discussed on the phone earlier the overall length of the trailer and truck that the Town of Bristol would pull the trailer with is 26' for the Mack Truck and 20' in length (including tongue) for a total of 45' in length. We will need to go on State roads as well as town roads. The trailer will be used to spread chloride on the town roads. The trailer width is 9'6" from outside fender to fender. The gross weight for the trailer is 18,000 lbs.

The questions we have are:

- Is the trailer considered to be oversize?
- Is the truck and trailer considered overlength?
- Is the municipality exempt from obtaining an overlength or oversize permit?
- If not, what is the process to obtain a blanket permit from May to September?

We have a Selectboard Meeting Monday night (3/4/19) so if we could obtain this information today or on Monday that would be great. We need to determine if we can buy the trailer and still be in compliance with State regulations.
